Subject matter must include sights and scenes of Warren County. Works can include, but are not limited to scenes from parks, theme parks, or festivals. Have fun bringing out the playful side of Warren County. Subject matter does not have to be a winter scene.

Awards Ceremony: Saturday, November 12, 2011 at 6:00pm

Exhibition Dates: The exhibition and sale will be open and free to the public Saturday, November 12, 2011 through Saturday, December 17, 2011.

Gallery Location: Gallery 42, 105 E. Main St., Mason, OH 45040

Gallery Hours: Tuesday through Friday, 10-6, Saturday, 11-3.

Eligibility: The exhibition is open to artists 18 years or older. **All work must be original in concept, design and execution.** Students must not present work for consideration if assisted in any way in arrangement or execution. Artists may be asked for an artist bio for display purposes.

Awards:

**1st Place - \$500.00 prize. Holiday Card cover for Rep. Peter Beck's card, work will hang in Mr. Beck's State House office.**

**2nd Place - \$250.00**

**3rd Place - \$100.00**

**Two Honorable Mention Awards will be awarded.**

Preparation of artwork: Size and weight of work is limited to that which can be moved by one person and no larger than 16" x20" in size. Only 8"x10", 11"x14", 12"x16" and 16"x20" format will be accepted. All work must be two dimensional.(Size and weight of work is limited to that which can be transported to and from the gallery.) Any work that is to be hung,, must be appropriately framed and wired, and strong enough to support the piece. Museum wrapped canvas is acceptable (please no staples or nails on the edges). The label provided in the entry form must be filled out and affixed to the back of the hanging piece or the bottom of a standing piece.

Entries: An entry fee of \$5.00 for each entry. Up to 4 pieces can be entered into the show.

Schedule: *Deadline:* For delivery of artwork for judging: **Tuesday, November 8, 2011**

*Submission of Artwork:*

- 1) Artwork should be delivered to Gallery 42 along with entry fees.

*Pick up of Accepted Artwork after show:* Work dropped off for show should be picked up by **Wednesday, December 21, 2011.**
